Raj previously served as a non-executive director of a national credit bureau and two publicly traded financial institutions in addition to serving on the Boards of many of the major banking, insurance, reinsurance and asset management subsidiaries of the firms he has worked for including Standard Life Aberdeen plc, Accedere AG, Swiss Reinsurance Company LTD, Allianz SE, and Citigroup. He is currently the Chief Risk Officer and Executive Committee member of EFG International, a Swiss private banking group.
